

GLOBAL HARDWARE SOLUTIONS SP. Z O. O. Privacy and Cookie Statement

GLOBAL HARDWARE SOLUTIONS SP Z O. O. ., registered at Osadnicza 1, 87-100 Toruń Polska (hereinafter: "Global Hardware Solutions Sp. z o.o", "we" or "us") is responsible for the processing of personal data obtained through the website <http://szkola-w-sieci.pl/pl/> (hereinafter: "Website"). In this Privacy and cookie statement we explain how we handle the personal data which we obtain from you.

We respect the privacy of our customers and the users of our Website and ensure that the personal information you provide us with is processed in accordance with the applicable data protection laws and regulations and is handled confidentially.

For the purpose of data processing, we comply with the standards according to the data protection laws. This means, amongst others, that:

- we **clearly state** for which **purpose(s)** we process the personal data. We do this by means of this privacy statement;
- we **limit collection of personal data** to only the personal data that is needed for the legitimate purpose(s);
- we first ask your **explicit permission** to process your personal data in cases where your permission is required;
- we take **adequate security measures** to protect your personal data and we require the same from third parties who we entrust to process personal data on our behalf;
- we respect your right to, **upon your request, provide you with insight in, correct, translocate, limit the processing or delete the personal data.**

From time to time this privacy and cookie statement will be amended. We will inform you about this by placing an updated version of the privacy and cookie statement on our Website. We recommend you to regularly consult this privacy and cookie statement, in order to stay aware of these changes.

This privacy and cookie statement has been lastly amended on 25 May 2018

Purpose(s) of data processing

We only process data which you have provided us with yourself through the Website or which we have obtained through your use of the Website. Summarizing, we only process the personal data you have provided us with for the following purposes:

1. To personalize the website for you and to be able to recommend you the products which you might find interesting.
2. To be able to answer your questions about, amongst others, our products and/or services.
3. If you react to our marketing campaigns.
4. To further develop and improve our website.

In addition phone conversations with the **GLOBAL HARDWARE SOLUTIONS SP. Z O. O.** customer service can be recorded for the purpose of training, coaching and appraisal of our staff. The records of such phone calls shall be secured and stored in such way that they are not available for non-authorized persons.

We will not process your personal data in another way than described above, unless you have granted us a prior permission to do so, or if it is necessary for the performance of any agreement that we have concluded with you or if we are allowed or obliged to do so pursuant to the law.

Use of personal data

We process the following categories of personal data for the purpose(s) as described in this privacy and cookie statement:

- Name and address (in some cases optional);
- Phone number;
- The questions you asked to our staff;
- IP-address;
- Cookie ID.

Security

We take appropriate security measures to prevent misuse of and unauthorized access to the personal data. In this respect, we ensure that only the necessary persons have access to your data, that access to your account data is shielded by a user name and a strong password and that our security measures are assessed on a regular basis. Besides, we use SSL-certificates for a safe transfer of your data and communication.

Providing data to third parties

We will not sell or provide your personal data to third parties without your prior approval or in cases other than necessary for processing of your order. It may also be possible that we are entitled or obliged to share these data pursuant to the law.

Storage period

We offer different services on our Website for which we may ask you for your permission to process your request (i.e. for processing of your question and/or processing of an order). Except for your e-mail address, you can determine yourself which data you will provide us with. The data you send us, will be stored for as long as necessary to execute your order or needed for a full response and processing of your request.

Cookies

We use cookies on our Website. A cookie is a small text file which is sent to your computer and stored by the browser on your computer at a visit of a website. Cookies store for example information about the settings of your pc and the indicated preferences, so you do not need to provide this information again and again and to facilitate your next visit to our Website. This information does not contain name, address or other personal data. You can adjust the settings of your browser in a way that you will not receive cookies during your visit on our Website. You can check the settings of your browser for this. However, if your browser refuses cookies, it can occur that you cannot use all options of our Website or that you do not have access to some parts of our Website.
